Risks & Aftercare

Potential Risks:

- Allergic reaction to adhesive, products, or materials (redness, swelling, itching)
- Eye irritation or sensitivity
- Damage to natural lashes (breakage, thinning) if improperly applied or maintained
- Infection if hygiene is not maintained
- Contact dermatitis

Aftercare Instructions:

- Avoid water and steam for 24-48 hours after application
- Do not rub, pull, or pick at your lashes
- Avoid oil-based products around the eye area
- Clean lash extensions daily with lash-safe cleanser
- Do not use a mechanical eyelash curler on extensions
- Schedule fills every 2-3 weeks to maintain fullness
- Do not attempt to remove extensions yourself — professional removal is recommended

For Lash Lift/Tint:

- Avoid water and makeup on lashes for 24 hours
- Do not rub or touch the lashes
- Results last 6-8 weeks
